22ND ANNUAL TRANSPORTATION DISTRICT LODGE 140 CONVENTION

Dear Members.

Due to the continuing variants of Covid-19, the 22nd Annual Transportation District 140 Convention has been postponed until October 2022. **As a result, the term of the currently elected Delegates and Alternates has expired.**

The 2022 Transportation District 140 Convention will now take place on October 25th, 26th and 27th 2022 in Ottawa, Ontario Canada. Nominations for Delegates to the 22nd Annual Transportation District 140 Convention will be called at the LL 16 General Meeting on February 15th 2022 and Elections will be held on April 19th 2022.

Interested members are encouraged to fill out a Nomination Form and return to the Recording Secretary of Local Lodge 16 by Canada Post or in person at the Level 4 YVR Domestic IAMAW Office.

All Nomination forms MUST be delivered to the Recording Secretary and recieved by no later than 15:00 pm on February.14TH, 2021.

Nominations offered at the Local Lodge General Meeting **require both** the **Nominee** and **Nominator** to be present in order for the Nomination to be accepted by the President. Both the **NOMINEE** and **NOMINATOR** must be "**Members in Good Standing**" of the Local Lodge for at least one (1) year at the time of nomination for the nomination to be accepted.

Due to the Covid-19 Pandemic and the cancellation of several General Meetings, nominees and nominators do not have to meet the eligibility requirements concerning attendance of fifty percent (50%) of the Local Lodge monthly meetings.

ABSENTEE BALLOTS - IAMAW CONSTITUTION - ARTICLE II - SECTION 3

Members who reside in outlying Districts more than 25 miles from the designated balloting place, members who are either confined because of a verified illness or on leave qualifying under U.S. and Canadian family leave laws, or on vacation, or on official I.A.M. business approved by the Local Lodge or District Lodge or Grand Lodge, or on an employer travel assignment, or reserve military leave, as the case may be, shall be furnished absentee ballots. Members applying for an absentee ballot on the basis of residing in an outlying district more than 25 miles from the designated balloting place, shall have their eligibility to vote by absentee ballot determined by the Recording Secretary and the Secretary Treasurer before the ballot is mailed. Members found not to be eligible to vote by absentee ballot will be so notified within 10 days of the receipt of their application.

Please fill out the attached **Absentee Ballot Request Form** and mail by Canada Post or hand deliver to the Recording Secretary **BY** and **NO LATER THAN 15:00pm MARCH.20,2022**. Additionally, Forms may also be obtained from your Chief Steward (s) or the Local Lodge Office.
