Dear Brothers and Sisters:

Further to our bulletin of January 17, 2022, the parties have agreed to meet with the assistance of our Mediator on February 18, 2022. The Company was unwilling to agree to additional dates. Your Negotiations Committee met internally yesterday to prepare for the upcoming mediation.

The Company's application for an essential service hearing remains in abeyance until February 18, 2022, while the parties tried to reach a tentative agreement in mediation. The Collective Agreement remains in full force and effect while the Company's application is before the CIRB.

We understand that these delays cause frustration, unfortunately we are required to follow the process in the legislation. If you have questions or concerns, please address them to the elected Members of the Negotiations Committee or refer to official communications from the Committee.

Your Committee continues to fight to improve upon and protect provisions of the Collective Agreement that are of critical importance to the Membership. Thank you for your continued support, patience, and solidarity, and for your continued professionalism in preserving the safety and security of the public.

We will keep you apprised of any developments in the process.
