Dear Members:

Last week we held Membership Information Sessions, via Zoom on the status of Collective Bargaining, relevant legislation, and a summary of the outstanding issues to be referred to mediation and interest arbitration.

Thank you for your participation, your feedback and for sharing your concerns. There were many great questions, and good dialogue, we hope that you found the sessions informative.

We are busy preparing for the mediation on September 1, 2022 and wanted to let you know that the interest arbitration dates have been moved to September 8 and 9, 2022 resulting from a change in the Arbitrator's availability. This will ensure that both parties will have sufficient time to prepare our adjudication briefs, following the mediation, and in advance of the interest arbitration. We will provide a further update following the mediation.

Once we receive the interest arbitration decision, further Membership Information Sessions will be scheduled to share the results, and to answer questions pertaining to the implementation of changes to the Collective Agreement.

Your Negotiations Committee thanks you for your continued support, patience and solidarity and commends you for your continued professionalism in preserving the safety and security of the public.
