RE: MINIMUM MONTHLY DUES EFFECTIVE JANUARY 2023

The Local Lodge minimum monthly dues rate is calculated as follows:

2023 Grand Lodge monthly per capita	\$41.17
2023 District 140 monthly per capita	\$19.71
2023 BC Federation of Labour	<u>\$0.82</u>
2023 LL 16 minimum monthly dues:	\$61.70

As per Article 14.11(b), DL140 will establish the minimum Local Lodge monthly dues. We have just received the increases from Grand Lodge (see Grand Lodge Letter) and based on those increases, the Constitution and our District Lodge By-laws, the **2023** minimum dues rate for **Local Lodge 16** will be set at **(\$61.70)**.

As per the official correspondence from the Grand Lodge. The Consumer Price Index (CPI) has increased by **7.66%**. Along with an adage for Grand Lodge Convention Fund \$0.25 & IAM Disaster Relief Fund \$0.05. Therefore, Grand Lodge per capita tax will increase from \$37.96 to **\$41.17, effective January 01, 2023**

As per the language afforded on the official correspondence from Grand Lodge – “Those District Lodges which are above the minimum District Lodge per capita tax, as computed above, will increase their District Lodge per capita in an equal amount to the increase in the minimum District Lodge per capita tax of **\$1.15**. Therefore, The District 140 per capita tax will increase from \$18.56 to **\$19.71, effective January 01, 2023**.”

The Local Lodge is responsible to advise all the employer(s), with the union dues amount to be deducted per member. Local Lodges are free to set the minimum dues higher than the District minimum set.

When advising the employers, a copy of the letter sent to the employer(s), should also be sent to the District 140 office in Montreal.
