Nominations are now open.

Nominations forms must be submitted to the recording secretary by May 15, 2023 @ 09:00.

Nominations will be accepted from the floor at the May 16, 2023 GM meeting *Floor nominations will occur* at the May 16, 2023 GM meeting

Elections will be done ONLINE, must register to vote. Election will occur on June 20, 2023. Should an in person poll be required it will be on June 20, 2023. Times will be communicated.

Committee break down is as follows;

(1) Northern bases NEGOTIATION COMMITTEE REPRESENTATIVE: Nominated/Elected from the Northern Bases, including Fort St. John and Prince George.

(1) **Island Bases** NEGOTIATION COMMITTEE REPRESENTATIVE: Nominated/Elected from the Island Bases, including Victoria, Nanaimo, Comox and Campbell River.

(1) **Interior Bases** NEGOTIATION COMMITTEE REPRESENTATIVE: Nominated/Elected from the Interior Bases, including Kelowna, Penticton, Cranbrook and Castlegar.

(8) **YVR Base** NEGOTIATION COMMITTEE REPRESENTATIVE: Nominated/Elected from the Lower Mainland, including Vancouver (YVR).

Members will only be permitted to seek nomination and vote within their region.

NOMINATIONS for the above offices may be offered at the Regular Local Lodge 16 meeting on May 16,2023. If the Nomination is offered at the Regular Lodge Meeting, the **NOMINATOR** and the **NOMINEE** must be present at the Meeting for the Nomination to be accepted from the floor by the President.

Both the **NOMINEE** and **NOMINATOR** must be "**Members in Good Standing**" of the Local Lodge for the Nomination to be accepted.

NOMINEES must meet the Local Lodge Regular Meeting attendance requirements (50%), as specified in Article 2, Sections (H) & (I) of the Local Lodge Bylaws. Constitution and be a "member in good standing" for at least one (1) year at the time of nomination for the nomination to be accepted.

IAMAW CONSTITUTION – ARTICLE II – SECTION 3 – ABSENTEE BALLOTS

Members who reside in outlying Districts more than 25 miles from the designated balloting place, members who are either confined because of a verified illness or on leave qualifying under U.S. and Canadian family leave laws, or on vacation, or on official I.A.M. business approved by the Local Lodge or District Lodge or Grand Lodge, or on an employer travel assignment, or reserve military leave, as the case may be, shall be furnished absentee ballots. Members applying for an absentee ballot on the basis of residing in an outlying district more than 25 miles from the designated balloting place, shall have their eligibility to vote by absentee ballot determined by the Recording Secretary and the Secretary Treasurer before the ballot is mailed. Members found not to be eligible to vote by absentee ballot will be so notified within 10 days of the receipt of their application.
