Dear Members:

We were notified by AUS that there will be a single deposit on April 12, 2024, which will include final earnings and the payout of accrued vacation, all subject to the regular statutory withholdings.

The national Allied Universal payroll team will remain available for any questions as to final pay information until the end of May 2024. Should you have a question, we ask that you collect and provide as much information as possible to ensure a swift and accurate response by our team. For these inquiries, please use the following email address: aviation.pay@aus.com. Your pay stubs will continue to be available through your individual access using ADP through 2025.

Your Record of Employment (ROE) will be issued following the final pay on April 12, 2024 and should be available in the Service Canada system by April 19, 2024. Allied Universal will not be sending individual copies of ROEs. To access your record of employment, please refer to information from the Government of Canada found here.

Effective March 31, 2024 at 00:00, PASS is responsible for all wage related matters. The first payroll deposit for the period covering April 1, 2024 through April 6, 2024 will be deposited on April 12, 2024 and will reflect the new wages rates in effect.

All accrued hours of work have been shared with the IAM and PASS to support progression on the Appendix A wage scale. We do not yet have a timeline as to when this data will be imported into the payroll system and will update you with this information once we know.

All hours worked for March 31, 2024 have been shared with the IAM and PASS to ensure an accurate calculation of regular hours worked/paid for the week of March 31, 2024 – April 6, 2024, towards any applicable overtime rates that may apply.

We will keep you apprised on matters related to the transition of payroll, as we are notified.
