EMPLOYED AS SCREENING OFFICERS (PASS) LOCAL 16 – PACIFIC REGION COLLECTIVE BARGAINING UPDATE

Dear Members:

We met in direct bargaining with PASS October 7 - 9, 2024. The parties discussed several housekeeping matters mostly related to the transition, exchanged our non-monetary bargaining agendas and began discussing non-monetary proposals.

The majority of the first day was spent discussing the work environment and concerns surrounding the lack of respect and dignity towards Screening Officers by representatives of the employer and in some cases by the regulatory body. Many of these concerns were shared by employees with the employer's senior management team during the onboarding process. Sadly, these same concerns have only worsened the past six (6) months and respect for Screening Officers has deteriorated further and led to inhumane working conditions.

We are scheduled to resume direct bargaining with PASS on November 26 - 28, 2024. Your Committee will strive for an agreement that delivers the right protections on the job, fair wages, benefits, job security, and the RESPECT and DIGNITY you deserve. We are all in this together, and our strength at the bargaining table is dependent on membership support.

We want to remind you that the Collective Agreement continues to be in full force and effect and that during this time you are obliged to work under the conditions of the present Collective Agreement and should at all times comply with screening procedures and follow the CATSA issued SOP's.

Your Negotiations Committee thanks you for your continued support, patience and solidarity and commends you for your continued professionalism in preserving the safety and security of the public.

We will keep you apprised of any developments in the process.
