TO ALL IAMAW MEMBERS EMPLOYED AS SCREENING OFFICERS (PASS) LOCAL 16 – PACIFIC REGION COLLECTIVE BARGAINING UPDATE

Dear Members:

The parties met virtually in direct bargaining on June 3 & 5, 2025, and were joined by our Conciliation Officer, Karlene Bateman. The sixty (60) conciliation period ended on May 30, 2025, and the parties have entered the twenty-one (21) day mediation phase. The parties will meet in-person on June 19 & 20, 2025 in our continued effort to reach a tentative agreement or at a minimum, to narrow issues in dispute.

On April 2, 2025, the employer filed an application pursuant to the section 87.4 of the Canada Labour Code, which deals with essential service levels or maintenance of activities, during a lock-out or strike. The parties agreed to hold the matter in abeyance until June 20, 2025. We will provide our reply submission when directed by the Canada Industrial Relations Board (CIRB).

Your Committee continues to strive for an agreement that improves upon and protects provisions of the Collective Agreement that are of critical importance to the Membership, including but not limited to compensation, benefits, job security, seniority, and scheduling provisions. We are all in this together, and our strength at the bargaining table is dependent on membership support.

We want to remind you that the Collective Agreement continues to be in full force and effect and that during this time you are obliged to work under the conditions of the present Collective Agreement and should at all times comply with screening procedures and follow the CATSA issued SOP's.

Your Negotiations Committee thanks you for your continued support, patience and solidarity and commends you for your continued professionalism in preserving the safety and security of the public.

Please attend or participate virtually in the Local 16 General Meeting on Tuesday, June 17, 2025 to support motions related to collective bargaining.

We will keep you informed of any developments in the process.
