Notice of Motion: (Second reading)

1. **Under Article 5 Funds and Expenses, new Section I (note that the membership approved a new Section H that deals with 'buy union') that reads as follows:**

"In the event of death of a member in good standing the union shall provide a tribute in the form of a gift basket or charitable donation not to exceed \$300.00."

2. **Under Article 6 Amendments New Section C:**

"The Executive Board working in conjunction with the Bylaws Committee, shall have the authority to make non-substantive editorial changes to these bylaws without requiring a vote from the membership. Such changes may include corrections to spelling, grammar, punctuation, formatting, numbering and cross-references, provided that the meaning or intent of the bylaw is not altered. A report of any such changes shall be provided to the membership at the next general meeting."

3. **The Bylaw Committee recommends that Article 2- Officers and their duties, Section I:**

"A member may be excused from attendance to the Local monthly meeting due to work schedule, employer out of town assignment, sick leave, bereavement leave, compassionate leave, union business, or scheduled vacation. In these cases the member will be considered as having been in attendance." "Evidence in support of any excused attendance must be provided to the Recording Secretary prior to or at the time of nomination."

To be amended, such that the last sentence be removed and replaced with:

"Any excused attendance must be provided to the Recording Secretary either seven (7) calendar days prior to or seven (7) calendar days after the general meeting the member cannot attend. The member shall indicate to the Recording Secretary the valid reason for not attending the general meeting."

4. **Local 16 to host a holiday event, cost not to exceed 10, 000 dollars.**

5. **Local 16 to provide shuttle service for the December Local Election, cost not to exceed 2000.00 dollars.**
