**NEW BYLAW:**

*“Moved that under Article 1 – Name and Time of Meeting, a new Section H (and renumbering the current Sections H, I, and J as I, J and K respectively) that reads as follows:*

*All monthly general meetings of Local 16 shall adhere to the following Order of Business:*

1. *Call to Order*
2. *Roll Call of Officers*
3. *Reading and Approval of Minutes*
4. *Treasurer’s Report*
5. *President’s/Chairperson’s Report*
6. *Chief Shop Steward Reports*
7. *Committee Reports*
8. *Unfinished (old) Business*
9. *New Business*
10. *Good and Welfare*
11. *Adjournment*

*When applicable nominations/elections shall be placed on the Agenda after Committee Reports but before Unfinished (old) Business.*

*A motion to suspend the regular order of business shall require a two-thirds majority of those members present at the meeting.”*

**NEW BYLAW:**

*Moved that under Article 5 Funds and Expenses new Section J (note that we have a proposed Section H and I already on the table (buy union and \$300 gift basket for deceased)):*

*“Any member in good standing who is required to be away from their regular care-giving duties due to participation in official union business such as conferences, courses or conventions shall be eligible to claim reimbursement for childcare expenses.*

*Reimbursement shall cover reasonable and necessary expenses paid to a licensed childcare provider. The maximum reimbursable amount and any applicable daily or hourly limits shall be established and periodically reviewed by the Executive Board.*

*Childcare expenses must be incurred specifically during the time the member is engaged in union business, including reasonable travel time to and from the union activity.”*

## BYLAW AMENDMENT

*Moved that Article 2, Section H that states:*

*"In order for any member to be eligible for nomination to a Local Lodge office or committee, shop steward, delegate or any Local Lodge sponsored convention, conference or seminar, the member must be in good standing for a period of one (1) year and have attended at least fifty percent (50%) of the regular Local Lodge monthly meetings in the preceding twelve (12) months of their nomination."*

*be amended to read as follows:*

*"In order for any member to be eligible for nomination to a Local Lodge office or committee, shop steward, delegate or any Local Lodge sponsored convention, conference or seminar, the member must be in good standing for a period of (1) year and have attended at least **thirty percent (30%)** of the regular Local Lodge monthly meetings in the preceding twelve (12) months of their nomination **unless otherwise specified in the Constitution or District 140 bylaws.**"*
